

**Q1 2026 Estimated Capital Gains Distributions (as of February 23, 2026)**

The Dodge & Cox Balanced and Stock Funds will make capital gains distributions in the first quarter of 2026. Estimated per share amounts and distribution dates are provided below.

The Dodge & Cox Stock, Balanced, Income, and Global Bond Funds typically distribute any capital gains realized between January 1 and October 31 to shareholders in December of the same year. Any capital gains realized in these Funds between November 1 and December 31 are typically made in March of the following year.

The International, Global Stock and Emerging Markets Stock Funds make one capital gains distribution, if necessary, in December.
