### Timing of Capital Gain Distributions

If a Fund has net capital gains through October 31, they are normally distributed to shareholders in December. If a second capital gain distribution related to the calendar year is necessary, it is usually made in March of the following year for the Stock Fund, Balanced Fund, Income Fund, and Global Bond Fund, and in December of the following year for the Global Stock Fund, International Stock Fund, and Emerging Markets Stock Fund.
